The MTA endorses the recommendations of the Special Commission on School Library Services in Massachusetts and will help to promote its report and recommendations through established MTA digital and print channels. The president of the MTA will also send letters of support for these recommendations to DESE and to members of the Massachusetts legislature.

The Special Commission on School Library Services in Massachusetts recommends:

- Improved access to school libraries and school librarians
 - o Every school needs a school library and a certified school librarian
 - DESE needs a School Library Curriculum Specialist to ensure equity in every school and to support a culture of inquiry in schools that sustains inquiry, and resource-based learning, collaborative teaching, and the integration of digital technology to improve access for all students
- Improved access to information resources in school libraries
 - Every school needs adequate infrastructure and devices, as well as print and electronic resources, to develop digital literacy, efficacy and safety
- Improved access to information technology
 - School librarians need continuing and high-quality professional development to deliver high quality, relevant instruction and help to students, teachers and administrators
 - o All students need improved access to internet and digital devices in school libraries
 - o All students need school library staffing that ensures adequate access to information technology
- Improved access to library instruction and help
 - o All students need access to the best instructional practices in their school libraries
- Improved access to funding

• All schools/districts need guidelines for budget allocation and expenditure to support these recommendations

SUBMITTER'S RATIONALE

• The Special Commission on School Library Services in Massachusetts submitted *The Massachusetts School Library Study: Equity and Access for Students in the Commonwealth* to the Legislature in February 2018. The Commission, which included educators, librarians, legislators, and members of the business community found that **Massachusetts public school students do not have equity when it comes to their school library programs.**

• All students deserve equitable access to key resources for learning, including school libraries with certified librarians and support staff.

• The recommendations address this inequity and provide clear guidelines on how to move forward.
